Meeting with Catoosa Mayor. They are not going to be needing any water from us.

15. Commercial Avenue Streetscape Lighting

Streetscape lighting - Mayor Garcia stated that we have the string lights up and there will be a \$14.98 charge monthly for this.

16. Black Bottom Soccer Field

Black Bottom soccer field - Mayor Garcia stated the MHS played their first game last week. He stated that the parking lot has been striped. He stated that he had an ideal to rename the field to Mayor Walker Memorial Field. Bill Wiggins stated he would like it to be Nathan Walker Sports Complex - Black Bottom Field. Chief Mackie stated that at the nights we play at home, we could have a reserve set there with a patrol car.

17. Electronic Updates for City Hall Meeting Room

Electronic updates for city hall meeting room - Mayor Garcia stated that in your packet is a cost of what it would cost to purchase tv's and we would have a shared tablet for two aldermen (total of 4 tablets). This would be less than \$2,500. Cecilia Paulson made a motion to table.

18. Address Water/Sewer Billing Error

Sewer billing error - Mayor Garcia stated that Jamie Phillips found the error from the software company. We have the error corrected. If you don't use more than 2,000 gallons, this will not affect the customer at all.

19. Discuss Parks Rules and Regulations Ordinance

Parks Rules and Regulations - Mayor Garcia stated that himself and Rafferty have been looking at these and we will have this for you in April.

Jerry Warren addressed the board concerning a TAP grant. This project has been in the works for around five or six years. There will be a few easements that we will need for this project.

Jerry Warren stated that the ARP grant is for the stormwater and is a 100% grant. He stated that we will need to get around five or six easements for this project.
