You and each of you are hereby notified that I have called a special meeting of the Board of Mayor and Aldermen of the Town of Monterey, Tennessee, to be held on Wednesday, October 30, 2024 at 6:00 p.m. at Monterey City Hall, for the purpose of:

2. Discuss cease and desist letter to be sent to the developer of Louis Avenue subdivision

Item 1. There was none.

Item 2. Mayor Garcia stated that while we are waiting on Nathaniel Green to get here, I have one more emergency item for the agenda. I have found three emergency vehicles on

gov deals and would like to get permission from the board to spend up to \$30,000 for these vehicles and use the military fund to pay for these. One is a Ford Econoline command unit, one is a Chevy Tahoe and the other is a Ford Explorer. They were used in Atlanta, at the Fulton County EMS. After further discussion, Cecelia Paulsen made a motion and was seconded by Spencer Delk to spend up to \$30,000 from the military account. After a roll call vote, all present voted yes. Motion carried.

Item 3. After discussion from Nathaniel Green and the board members Bill Wiggins made a motion and was seconded by Jamie Phillips to authorize a cease-and-desist letter be sent to Mr. Mike Callahan for any work performance for water and sewer lines and for this to be sent to TDEC for review and stamped and then brought back to the planning commission and the board of Mayor and Aldermen for approval. After a roll call vote, all present voted yes. Motion carried. It was also discussed about a sewer tap that possibly was made on an existing sewer line rerouting one home to the improper sewer line that has been installed without approval. It was discussed to give Mr. Callahan a chance to fix this before we fix it and bill him.
